Looks like 2016 is going to bring new challenges for us regarding FAA registration of our planes. The AMA is now saying to we have to register. You have until February 19th to be registered. If you are not registered and caught, there will be a very heavy penalty considering it is a federal offense. As Warren stated at the last monthly meeting, the registration number must be visible on every aircraft (without using any tools to get access, so local law enforcement can quickly see the number). At this point in time, registration is free. If you wait until after January 21st it will cost \$5.00.

By now you have probably seen Peter's note and possibly other information indicating that the FAA has shut down approximately 36 flying fields in the DC area. This could be a big problem for us as this could set a precedent such that every flying field in the country could potentially be shut down by the local politicians just because Washington has done it. So, if anyone has any more information about this or indications that our local politicians are contemplating shutting down our fields, let the board members know.

All that attended the Frost Fly had a great time! The members got a lot of flying in. The weather was superb. Thanks to Rob for bringing the coffee and donuts.

Have you registered with the FAA?

The AMA finally caved and said all members should register. You can do this by accessing https://registermyuas.faa.gov/ and filing out the form. Do not forget to check the "I accept" box at the bottom of the pages.

The February 1 meeting will be discussing Bylaws and Field Rule changes that need to be made to keep them current. The inclusion of mandatory government registration and AMA requirement that your registration number be on every aircraft to make it legal AND have insurance coverage will be discussed. In all likelihood this will be added to the Field Rules too.


The 50th Jamboree will reintroduce the "Mission Event". It is comprised of a bomb

drop, balloon bust and spot landing, all done in one flight. This is a judged event with scoring and requires 1 judge per pilot in addition to the manpower that handles the balloons and regular flight line personnel. It is anticipated that up to 3 mission pilots will be in the air simultaneously, that means we need at least 3 judges in addition to the spotters and normal flight line crew. I've already volunteered to be the data entry guy that runs Flavio's scoring system. Like I said, volunteer early and you get to pick your job.

Training is required for the judges. Training will be done in 2 sessions at the July and August field meetings along with practice of the mission event. A future newsletter will contain rules for the event.

Save these dates, July 9 and August 6, the field meeting dates are tentatively scheduled as training days for the judges of the mission event.
